SAMPLE SHIPMENT PROCEDURE

Copa Cervezas de América 2024

IMPORTANT: This document aims to clearly indicate how the registered beer samples should be sent to the Copa Cervezas de América 2024 competition. It complements the competition rules.

Responsibility and Scope

It is the responsibility of the person registering the beers in the competition to correctly identify, pack, and ship the samples to the address provided by the organization.

Once the samples are correctly received, it is the organization's responsibility to properly store and transport them.

Together with our sample reception centers, we commit to:

- Store the beer between 0 and 5 degrees Celsius (*)
- Move the beers as little as possible.
- Not expose the beers to the sun.
- Avoid abrupt temperature changes.

(*) Our effort is focused on achieving the highest number of cold storage facilities possible to maintain the beer at a temperature of 5°C.

Packaging Responsibility

The brewer must take special care in properly packing the beer bottles inside the box. Direct contact between bottles should be avoided, for which it is recommended to use packaging materials such as cardboard or bubble wrap to prevent impact and/or breakage.

It is the exclusive responsibility of the brewer to correctly pack the beer samples. The organization or the sample reception centers will not be responsible for inadequate packaging inside the boxes.

Courier

It is recommended to use a recognized courier for sending samples. Based on our experience, we recommend working with DHL.

Shipping Costs

The cost of shipping the samples to the Copa Cervezas de América facilities in Chile is the responsibility of the participant.

The shipment is made under the DDP Incoterm where the sender is responsible for the freight and importation costs in the destination country.

If Copa Cervezas de América needs to assist in the importation/release process, an administration fee of US\$100 per shipment plus the costs incurred to release/receive the samples will be charged.

Necessary Documentation for Shipping from Abroad

1. Commercial Invoice, Export Invoice, or Proforma Invoice:

1.a. Clear Identification of the Consignee

The consignee (receiver) and the notify party must be clearly identified.

1.b. Declared Value on the Invoice

It is **important to note** that the total value of the export invoice should not exceed US\$ 40 (Forty dollars). If the value exceeds this amount, Chilean customs will charge a tax for its entry:

- 6% import tax on CIF value (Cost + Freight + Insurance).
- 19% VAT on CIF value + 6% import tax.
- 205% alcohol tax on CIF value + 6% import tax.

Under no circumstances should the unit value of the beer (bottle or can) exceed US\$ 0.80 (80 cents of a US dollar).

The invoice must indicate:

- Incoterm: DDP (Delivery Duty Paid).
- Payment terms: Prepaid.

2. PL (Packing List) or Shipping Details.

Include a packing list where the following must be clearly identified:

- Brewing company.
- Name of the Beer.

- Type of container (can, bottle, etc.).
- Volume of the container.
- Alcohol content ABV.
- Number of units.

3. Letter of Authorization for Entry without Sampling or Analysis:

Attach the letter from the Chilean health authority SAG, responsible for the importation and commercialization of alcoholic beverages: [SAG Authorization Letter](#).

4. Condition for Shipping from Abroad:

The shipment must be made under the DDP Incoterm (Delivery Duty Paid), where the sender is responsible for shipping and importation costs to the destination country. If the organizers need to assist in the importation/release process, an administration fee of US\$100 per shipment plus a reimbursement of the costs incurred during the process will be charged.

Sample Identification

Each bottle must clearly indicate the Registration Number. The Registration Number corresponds to the unique identifier of the registered beer, consisting of 5 digits, and is provided through the registration platform on the automatically generated label as per the example detailed below.

The package or box must identify on its exterior the number of bottles and the registration number of each registered beer contained in that box or package.

Sample Quantity

Participants must send the following number of samples according to the size of their bottles.

Bottle or Can Size	Number of Samples
Containers smaller than 499 cc (16.8 oz)	5 units
Containers between 500 cc (16.9 oz) and 750 cc (25.3 oz)	4 units
Containers larger than 750 cc (25.3 oz)	3 units

Bottle/Can Labeling

It is **mandatory** that the samples are identified with their commercial label. If there is no commercial logo to identify the beer, it must be replaced with a sticker from the brewery to which it belongs.

Bottles **MUST NOT** have neck labels or any identification on the neck of the bottle. It is the brewery's responsibility to remove the neck label before sending the samples.

Reception Deadline

Samples will be received within a defined time window, the same for all participants. Samples that are not received within the indicated deadlines, either before or after the defined dates, will be excluded from the competition.

The registration fee will not be refunded for samples that do not arrive at the competition.
